- S/M Secretary once again read the "Save the Date" for the NCR Mid-Year Conference being held in Springfield, MO April 6-9, 2023 at the Oasis Hotel and Convention Center, 2546 N. Glenstone Ave.

NEW BUSINESS:

- Results of the 8 Resolution submitted at the National Convention
 - Passed. If passed, would allow officers who served or are now serving in the Navy, Marine Corps and Coast Guard to join the FRA
 - 2. **Passed.** If passed, would require branches to purchase all year's continuous membership pins.
 - 3. **Failed.** If passed, would have dues for first time members who sign up between 11 Nov 2023 and 10 Nov 2025 be free and require them to pay \$24.00 for the second year.
 - 4. **Failed.** If passed, would have branches pay an administrative fee equal to one-half of the current dues for members they carry as exempt.
 - 5. **Passed.** If passed, would eliminate C&BL Sec 401(m). Members who attain the age of 85 with 40 years continuous membership would be exempt from paying dues. Members who are already receiving this benefit will continue to be exempt from paying dues.
 - 6. Passed. If passed, changes the Life Membership fee. See additional article in the November Newslettrer
 - 7. **Failed.** Ruled out of order (C&BL conflict). If passed would have allowed the NED (National Executive Director) to be an FRA member or hired from outside the association.
 - 8. **Failed. Ruled out of order (C&BL conflict).** If passed, would allow the National Board of Directors to appoint a designated representative to advertise the NED position, review resumes and make recommendations to the NBOD. The NBOD would then hire the best-qualified candidate.
- We have signed up for the Willard Veterans Day Parade November 4th .We need riders.
- We have signed up for the Marshfield Veterans Day Parade November 11th. We need riders.

Our group celebrated 5 years of existence recently and that's quite a milestone for us. Some marriages have not made it that long. Fortunately, for us we continue to meet, reminding me of this saying "a little+often= a lot".

Holly, my co-facilitator, is planning on being at the Stand Down introducing and recruiting new members at a table, stop by and see her if you get the chance.

Our group has talked about being "grounded" on occasion. What this means is that you are aware of what is happening outside of your body/environmentally and inside of your body/internally. Often our

perceptions of what is happening enter our behaviors. Grounding involves dealing successfully with these perceptions before they become troublesome. This can be done by noticing where you are, who is around you, and what is happening to you, physically or emotionally.

Noticing where you are in what you are doing or how you respond in that place and time may adversely affect how you react. If you are with friends or family doing something that is normally fun and you hear a loud sound, hear thunder, get startled by someone, or the loud explosions of fireworks, these triggers will need to be dealt with. You might get away from surprises like these, but the best solution is avoiding potential situations that may bring about or prompt these difficult reactions. Physically, your heart may speed up, blood pressure goes up, your breathing becomes rapid or you begin to feel confused or sweat, however, your being grounded can help you realize what is happening and do something about it.

Next month we will talk about more of the emotional aspects of dealing with stressful situations and getting "grounded".
